AGENDA ADDITIONS, DELETIONS, MODIFICATIONS

Comm. Brooks made a motion to approve the agenda with the correction of the item on the agenda under Planning Department concerning the Black Prong Equestrian Village. This is a request for approval of Ordinance 2022-8 and not a Petition. Comm. Brooks also wished to add a non-agenda item concerning a request for approval of a Resolution for Emergency Management to be presented by John MacDonald. Second was made by Comm. PUBLIC COMMENT

Maria Wise, Morriston resident spoke of the Black Prong item and expressed concerns of a traffic crossing of CR337. She requested a condition be added to the PUD to include a traffic crossing.

Diane Garte, Morriston resident spoke to the Board regarding the Black Prong mini storage and irregularities regarding the size of the project and of the septic system as well as light pollution produced from the project.

Ryan Asmus, FDOT Representative spoke to the Board providing an update of the US 19 P&E Kick-Off Study from Red Level to NW 140th Street. Mr. Asmus spoke of a Public Meeting being held this evening in Chiefland regarding a re-surfacing project NW 60th Street and NW 140th Street.

Comm. John Meeks requested FDOT look into extending the left turn lane at the intersection of SR 27 and SR24, approaching the new Marathon gas station.

Comm. Rock Meeks read into public record an email received regarding recent storm damage. John MacDonald also spoke of roadway clearing and stated most of the clean-up of trees was done by the Inglis/Yankeetown area residents. He also stated the County can only remove trees if they are on County right-of-way's, not on private property.
