 <u>Public Hearing</u> – Requesting Board approval of Ordinance No. 2022-10; an Ordinance of Levy County, Florida, amending the text of the Land Development Code Related to Accessory Dwelling Units and Associated Definitions; providing for inclusion in the code; providing a severability clause; providing a repealing clause; providing a transition clause and providing direction to the Clerk and an effective date.

Comm. Rock Meeks asked if anyone in the audience wished to speak regarding the item presented.

Members of the audience who spoke were: Terry Witt, Jason Whistler and Renate Cannon.

Salvatore Digregorio spoke to the Board concerning his wish to place a second dwelling on his property of  $2\frac{1}{2}$  acres, which was formerly two parcels of  $1\frac{1}{4}$  acre each and was combined by filing a Unity of Title. Mr. Digregorio stated this was not allowed since he has homesteaded property in St. Petersburg, Florida. He inquired if there was a way around this restriction.

Mrs. Hectus stated second dwellings were only allowable on homesteaded property in Levy County. Comm. John Meeks suggested he file documentation to return the property to two separate parcels. Mrs. Hectus stated her office is working on a process for land owners to do this.

Comm. John Meeks made a motion to approve Ordinance 2022-10 as presented. Second was made by Comm. Rooks and the MOTION CARRIES.
