MINUTES

The minutes for the following meetings were presented for Board approval: Special Meeting, June 26, 2023, Regular Meeting, July 11, 2023, Regular Meeting, July 25, 2023, and Final Budget Workshop, August 1, 2023.

Comm. Mills made a motion to approve the minutes for the meetings listed above as requested. Second was made by Comm. John Meeks and the MOTION CARRIES.

AGENDA ADDITIONS, DELETIONS, MODIFICATIONS

Comm. John Meeks made a motion to approve the agenda with no changes. Second was made by Comm. Mills and the MOTION CARRIES.

PUBLIC COMMENTS

Inglis resident, Roger Wimer spoke of his request at the previous meeting for a walkway at the Bird Creek Bridge and a change in signage. Comm. Mills responded to Mr. Wimer’s inquiry, stating she had previously informed him fishing from navigable waters was illegal in the State of Florida and found it was not feasible to construct a walkway in this area.

Morriston resident, Rose Fant spoke of her complaint filed with Code Enforcement against neighboring property owner, Alan Fant for continuing unauthorized dumping. She encouraged the Board to enforce the recently adopted Ordinance against such activity.

DOT representative, Amanda Handley provided an update to the Board of DOT’s efforts of putting together a Community Working Group for the City of Chiefland as part of the US19 PD & E Study. A committee has been formed and a meeting date has been set for September 14th at the Tommy Usher Center from 5:50 P.M. – 7:30 P.M. She stated the meeting is open to the public.

BUSINESS OR INFORMATIONAL ITEMS

LEVY COUNTY COMMISSIONER, DESIREE MILLS

Comm. Mills stated a business interested in purchasing the old Levy County Attorney Building (Baker Building) and old First Federal Building had contacted her. She inquired of the process allowing the sale of these 2 properties to take place.

Mr. Dean replied the properties would need to be made surplus and could then be advertised for sale. Atty. Shalley stated since the county has no adopted Real Property Policy, the process would be to surplus the property as per statute and then do an invitation to bid, selling to the highest bidder.

Comm. Mills made a motion to surplus the old Levy County Attorney Building (Baker Building) and the old First Federal Building, currently occupied by Building and Zoning. Second was made by Comm. John Meeks and the MOTION CARRIES.

Diane Garte spoke of the bid process for the sale of the property discussed.

SHERIFF’S OFFICE/911

Nicole Gore requested on behalf of Mike West Board approval of Resolution 2023-41 approving a budget amendment in the amount of \$1,085,884 for FY 22-23 and FDLE LESA Grant Agreement. The LCSO has been awarded the LESA grant through FDLE to assist in funding starting pay increases for all sworn LE and Corrections personnel of the LCSO.

Comm. John Meeks made a motion to approve Resolution 2023-41 and Grant Agreement as presented. Second was made by Comm. Mills and the MOTION CARRIES.

SUPERVISOR OF ELECTIONS

Tammy Jones

- A. Requesting Board approval to relocate the Precinct 6 Election Day polling place from Gulf Hammock Church of God to Otter Creek Baptist Church.
- B. Requesting Board approval to relocate the Precinct 12 Election Day polling place from Fanning Springs City Hall to College of Central Florida, Jack Wilkinson, Levy Campus.

Comm. Mills made a motion to approve the relocation of Precinct 6 and Precinct 12 Election Day polling places as requested. Second was made by Comm. John Meeks and the MOTION CARRIES.

- C. Requesting Board approval of Resolution 2023-40, amending the final budget for FY 2022-2023 in the amount of \$68,461 due to receipt of additional revenue from an Elections Security Grant.

Comm. Rock Meeks made a motion to approve Resolution 2023-40 as requested. Second was made by Comm. Mills and the MOTION CARRIES.

- D. Requesting Board approval of the Amendment to the BOCC budget in the amount of \$12,680 to appropriate funding to the Supervisor of Elections for DOR adjustment to salaries, FY 23.

Comm. John Meeks made a motion to approve the budget amendment for the Supervisor of Elections as requested. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

COUNTY COORDINATOR

Wilbur Dean

Requesting the Board ratify the Collective Bargaining Agreement (CBA) between the BOCC and Levy County IAFF Local 4069 with the Chairman’s signature, effective through September 30, 2024. The CBA allowed 2 articles per side to be opened for negotiations; 8: Hours of Work and OT; 9: Probationary Period; 19: Wages, and 30: Seniority.

Comm. John Meeks made a motion to ratify with the Chairman’s signature the Collective Bargaining Agreement as presented. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

Mr. Dean informed the Board the Agreement was received yesterday from the LIUNA 630, signed by their business agent.

PROCUREMENT

Alicia Tretheway, Coordinator

- A. Kimley-Horn representative, Elisabeth Manley gave a presentation to the Board of proposed Levy County Park (Concept A & B) to be located across the street from the Levy County Government Center.

Levy County Historical Society President, Toni Collins, spoke in opposition of the proposed park, as the property is located adjacent to the Historical Coulter Cemetery. She also pointed out, the Town of Bronson already has a large public park.

The Commissioners agreed by consensus to hold a Community Workshop for public input on this item.

- B. Kimley-Horn representative, Elisabeth Manley gave a presentation to the Board of proposed Landscaping Plans for the Levy County Government Center.

The Commissioners indicated they were pleased with the proposed plans as presented.

- C. Requesting the Levy County Board of County Commissioners’ review and approval of the Project Description/Scope of Services for State Lobbyists Services.

Comm. John Meeks made a motion to approve the Project Description/Scope of Services for State Lobbyists Services as requested with direction for staff to request an RFP for the position. Second was made by Comm. Mills and the MOTION CARRIES.

- D. Requesting Board approval of the lowest responsive responsible bidder Cortez Heating & Air, LLC (ITB_2023_014) for the replacement of the Air Conditioning Units in the Levy County Government Center Auditorium in the amount of \$37,687. The 3 bids received were:

PARKS AND RECREATION

Matt Weldon, Director

Requesting Board approval of a Budget Amendment from Contingency to correct shortage of \$3,300 to Contract Services for the Dubois Resources, Inc. Contract for Devil’s Hammock Wildlife Area check station. The Parks & Recreation Department’s 2023 budget for contract services was set at \$23,400 before the new Contract with Dubois Resources was finalized. The Contract amount is \$26,650 and the budget amendment will correct the difference.

Comm. Mills made a motion to approve the Budget Amendment as presented. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

ROAD DEPARTMENT

- A. Requesting Board approval of Resolution 2023-36 to advertise a Public Hearing for the closure and abandonment of portions of right of way lying within the plat of the Town of Ambler (known as the Town of Montbrook), located in Levy County, Florida.

Comm. John Meeks made a motion to approve Resolution 2023-36 as requested. Second was made by Comm. Comm. Mills and the MOTION CARRIES.

- B. Requesting Board approval of Resolution 2023-37 to advertise a Public Hearing for the closure and abandonment of a portion of Tenth Street within the plat of Oakdale Heights, located in Levy County, Florida.

Comm. Hodge made a motion to approve Resolution 2023-37 as requested. Second was made by Comm. Mills and the MOTION CARRIES.

SHIP

- A. Requesting Board approval of Deferred Payment Loan Agreement in the amount of \$30,000 for Ronetta Latrease Thomas and Davarus Rashad Rush, PA #608 for an existing unit in Williston, FL.

Comm. Rock Meeks made a motion to approve the Deferred Payment Loan Agreement for Ronetta Latrease Thomas and Davarus Rashad Rush as presented. Second was made by Comm. John Meeks and the MOTION CARRIES.

- B. Requesting Board approval and the Chairman's signature for the Levy County SHIP Annual reports for closeout period 2020-2021 submitted to the Florida Housing Finance Corporation (FHFC).

Comm. Mills made a motion to approve with the Levy County SHIP Annual reports for closeout period 2020-2021 with the Chairman's signature as requested. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

TRANSIT

Anna Elkins on behalf of Connie Conley, Director

- A. Requesting Board approval of Resolution 2023-35 amending the final budget for FY 2022-2023. The Trip & Equipment Grant award for 2023/2024 is in the amount of \$400,712 for a reimbursement amount of \$360,642 and began July 1, 2023.

Comm. John Meeks made a motion to approve Resolution 2023-35 as presented. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

- B. Requesting Board approval of the Title VI Plan update. The FDOT required an update of the Title VI Plant into a new template.

Comm. Mills made a motion to approve the Title VI Plan update as presented. Second was made by Comm. Hodge and the MOTION CARRIES.

PLANNING & ZONING

Stacey Hectus, Director

Swearing in of audience members was done by Atty. Shalley.

Comm. Brooks asked if any of the Commissioners had any ex-parte communication with the Petitioner. There was none.

- A. Requesting Board approval of Petition No. PP 23-02: McMillen Surveying, representing Sandra Beamer of Suggs' Estates, petitioning the Commission for a Preliminary Plat to Subdivide 52.817 acres, into eight (8) parcels of 5 to 10 acres MOL. Said parcel is located in Section 34, Township 12, Range 18 in Levy County, Florida with a land use of Urban Low Density Residential (ULDR) 1/1 and Zoning of Urban Single Family Residential, (R-1). Parcel number is: 0427000000.

Comm. Brooks asked if anyone in the audience wished to speak regarding the item presented. There was none.

Comm. John Meeks made a motion to approve Petition No. PP 23-02 as presented. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

- B. Requesting Board approval of Petition No. PP 23-03: McMillen Surveying, representing Jackie Willington of Hideaway Hills, petitioning the Commission for a Preliminary Plat to Subdivide 12.788 acres, into three (3), four (4) acre parcels MOL. Said parcel is located in Section 30, Township 12, Range 18 in Levy County, Florida with a land use and zoning of Rural Residential (R-R) 1/3. Parcel number: 0422400200.

Comm. Brooks asked if anyone in the audience wished to speak regarding the item presented. There was none.

Comm. John Meeks made a motion to approve Petition No. PP 23-03 as presented. Second was made by Comm. Mills and the MOTION CARRIES.

The meeting recessed at 10:53 A.M.

The meeting reconvened at 11:01 A.M.

- C. **INFORMATION:** Staff presentation by Legal, Engineering, Planning & Zoning, and the Health Department informing the Commission of the July 1, 2023 State law changes under the Department of Environmental Protection. These regulations require parcels of one acre or less, in the BMAP areas, to connect to central sewer or upgrade to an enhanced nutrient-reducing septic system if sewer is unavailable. The new law also requires updates to the Comprehensive Plan. On July 1, 2023, FDEP notified Levy County the Clean Waterways Act requires local governments within a Basin Management Action Plan (BMAP) area to develop a wastewater treatment plan and/or an Onsite Sewage Treatment/Disposal System (OSTDS) remediation plan. Portions of Levy County lie within 2 different BMAP areas; the Rainbow River BMAP and the Suwannee River BMAP.

Ethan, from the Levy County Health Department spoke regarding the new septic requirements.

Andrew Carswell, County Engineer spoke regarding the BMAP's in Levy County.

Inglis Mayor, Steven Schwing expressed concerns of the cost to the residents of the required inspections to the new septic systems.

Rose Fant expressed concerns of the possibility of restrictions for farmers who use fertilizers on their crops in these areas.

Ms. Hectus requested direction from the Board for the Planning Department to draft a letter, to be approved and signed by the Chairman, and sent to DEP, making them aware of Levy County's current Unity of Title process to prevent re-platting of existing property.

The Commissioners agreed by consensus to direct Ms. Hectus to move forward with the drafting of a letter, as described.

Ms. Hectus then requested consensus by the Board to work with Ali Tretheway to seek a consultant from the existing list to assist with their Remediation Plan, Fertilizer Enforcement, Fertilizer Ordinance, draft and Comp Plan Policies. These all must be presented in draft format by February, the Comp Plan Policies by July.

The Commissioners gave direction for Ms. Hectus to work with Ali Tretheway to seek a consultant as requested.

PUBLIC COMMENT

Sallie Ann Collins spoke of property size and the new septic requirements.

Town of Inglis, Mayor Schwing spoke to the Board regarding the previous request made by the Town of Inglis for Levy County to continue providing inspection/permitting services. He stated the Town is having a difficult time finding an inspector to perform these services and asked if the County could continue until they find someone. The Commissioners agreed to continue with the deadline for Levy County to provide inspection/permitting services for the Town of Inglis.

Sue Beaudette stated there would be a "meet and greet" time with Nikki Freid tomorrow at the new school building at 11:30 A.M. The "Bread of the Mighty" food drive will take place this Friday and the time has been changed to 9:30 A.M. due to the summer heat. Ms. Beaudette reported of the Waccasassa Water and Wastewater Cooperative Board meeting held last Wednesday in Cedar Key, stating everything was still moving forward and they now have a post office box. Wednesday, September 20th at 1:00 P.M. is the date and time for the next meeting and it will be in Otter Creek.

COMMISSIONERS' REPORTS

Comm. Mills stated the Affordable Housing Committee is planning their Annual Workshop and the date will be October 14th. Comm. Mills inquired of the status of new microphones for the Commissioners, which Mr. Dean responded Ali Tretheway had been in contact with someone and they have been ordered. Comm. Mills also stated she was excited about the landscaping presentation for the Government Annex as it was a step in the right direction.

Comm. Hodge stated he was interested in hiring a Grants Coordinator previously budgeted as this could greatly benefit the County.


Mr. Dean stated they are seeking firms for help with specific Grants, rather than hiring a Grants Coordinator.


Comm. John Meeks reported there will finally be a caution light installed at the intersection of CR326 and CR341.



INSTRUCTIONS FOR COMPLIANCE WITH SECTION 112.3143, FLORIDA STATUTES

A person holding elective or appointive county, municipal, or other local public office **MUST ABSTAIN** from voting on a measure which would inure to his or her special private gain or loss. Each elected or appointed local officer also **MUST ABSTAIN** from knowingly voting on a measure which would inure to the special gain or loss of a principal (other than a government agency) by whom he or she is retained (including the parent, subsidiary, or sibling organization of a principal by which he or she is retained); to the special private gain or loss of a relative; or to the special private gain or loss of a business associate. Commissioners of community redevelopment agencies (CRAs) under Sec. 163.356 or 163.357, F.S., and officers of independent special tax districts elected on a one-acre, one-vote basis are not prohibited from voting in that capacity.

For purposes of this law, a "relative" includes only the officer's father, mother, son, daughter, husband, wife, brother, sister, father-in-law, mother-in-law, son-in-law, and daughter-in-law. ELECTED OFFICERS:

WITHIN 15 DAYS AFTER THE VOTE OCCURS by completing and filing this form with the person responsible for recording the minutes of the meeting, who should incorporate the form in the minutes.

APPOINTED OFFICERS:

Although you must abstain from voting in the situations described above, you are not prohibited by Section 112.3143 from otherwise participating in these matters. However, you must disclose the nature of the conflict before making any attempt to influence the decision, whether orally or in writing and whether made by you or at your direction.

IF YOU INTEND TO MAKE ANY ATTEMPT TO INFLUENCE THE DECISION PRIOR TO THE MEETING AT WHICH THE VOTE WILL BE TAKEN:

- You must complete and file this form (before making any attempt to influence the decision) with the person responsible for recording the minutes of the meeting, who will incorporate the form in the minutes. (Continued on page 2)

- A copy of the form must be provided immediately to the other members of the agency.
- The form must be read publicly at the next meeting after the form is filed.

IF YOU MAKE NO ATTEMPT TO INFLUENCE THE DECISION EXCEPT BY DISCUSSION AT THE MEETING:

- You must disclose orally the nature of your conflict in the measure before participating.
- You must complete the form and file it within 15 days after the vote occurs with the person responsible for recording the minutes of the meeting, who must incorporate the form in the minutes. A copy of the form must be provided immediately to the other members of the agency, and the form must be read publicly at the next meeting after the form is filed.

INSTRUCTIONS FOR COMPLIANCE WITH SECTION 112.3143, FLORIDA STATUTES

A person holding elective or appointive county, municipal, or other local public office **MUST ABSTAIN** from voting on a measure which would inure to his or her special private gain or loss. Each elected or appointed local officer also **MUST ABSTAIN** from knowingly voting on a measure which would inure to the special gain or loss of a principal (other than a government agency) by whom he or she is retained (including the parent, subsidiary, or sibling organization of a principal by which he or she is retained); to the special private gain or loss of a relative; or to the special private gain or loss of a business associate. Commissioners of community redevelopment agencies (CRAs) under Sec. 163.356 or 163.357, F.S., and officers of independent special tax districts elected on a one-acre, one-vote basis are not prohibited from voting in that capacity.

For purposes of this law, a "relative" includes only the officer's father, mother, son, daughter, husband, wife, brother, sister, father-in-law, mother-in-law, son-in-law, and daughter-in-law. A "business associate" means any person or entity engaged in or carrying on a business enterprise with the officer as a partner, joint venturer, coowner of property, or corporate shareholder (where the shares of the corporation are not listed on any national or regional stock exchange).

* * * * *

ELECTED OFFICERS:

In addition to abstaining from voting in the situations described above, you must disclose the conflict:

PRIOR TO THE VOTE BEING TAKEN by publicly stating to the assembly the nature of your interest in the measure on which you are abstaining from voting; *and*

WITHIN 15 DAYS AFTER THE VOTE OCCURS by completing and filing this form with the person responsible for recording the minutes of the meeting, who should incorporate the form in the minutes.

* * * * *

APPOINTED OFFICERS:

Although you must abstain from voting in the situations described above, you are not prohibited by Section 112.3143 from otherwise participating in these matters. However, you must disclose the nature of the conflict before making any attempt to influence the decision, whether orally or in writing and whether made by you or at your direction.

IF YOU INTEND TO MAKE ANY ATTEMPT TO INFLUENCE THE DECISION PRIOR TO THE MEETING AT WHICH THE VOTE WILL BE TAKEN:

- You must complete and file this form (before making any attempt to influence the decision) with the person responsible for recording the minutes of the meeting, who will incorporate the form in the minutes. (Continued on page 2)

APPOINTED OFFICERS (continued)

- A copy of the form must be provided immediately to the other members of the agency.
- The form must be read publicly at the next meeting after the form is filed.

IF YOU MAKE NO ATTEMPT TO INFLUENCE THE DECISION EXCEPT BY DISCUSSION AT THE MEETING:

- You must disclose orally the nature of your conflict in the measure before participating.
- You must complete the form and file it within 15 days after the vote occurs with the person responsible for recording the minutes of the meeting, who must incorporate the form in the minutes. A copy of the form must be provided immediately to the other members of the agency, and the form must be read publicly at the next meeting after the form is filed.
