DEPARTMENT REPORTS

LEVY COUNTY COORDINATOR

Wilbur Dean presented the Cooperative Forestry Assistance Program Annual Report to the Board including the summary of the activities the Levy County Forester has participated in on behalf of Levy County in the 2020-2021 State fiscal year. It is presented as part of the cooperative agreement between Levy County and the Florida Forest Service, a part of the Department of Agriculture and Consumer Services.

PLANNING & ZONING

Stacey Hectus, Director

Ordinance 2022-1 and Ordinance 2022-2 will be moved to the January 18, 2022 Board meeting at 6:00 P.M. due to an oversight at the local newspaper. Legal ads were never ran. This was noticed to the surrounding owners via signs and letters to be presented at the January 4, 2022 Board meeting, but because the ads were not run, they have to be postponed to January 18, 2022.

Ms. Hectus spoke to the Board explaining the situation in which the ads were not run as expected. She expressed her frustration with the local newspaper and stated she would like to look into using a different newspaper, one which runs daily. Ms. Hectus stated she would have an action item to present to the Board on January 18th stating she is in need of replacement members for the Board of Adjustments.

Comm. John Meeks stated he was in favor of Ms. Hectus using the Gainesville Sun for legal advertisements. Linda Cooper also spoke regarding this item.
