Ms. Hectus read the Ordinance title into public record.

B. Requesting Board approval and the Chairman's signature on Resolution 2023-5 to amend the final budget for FY 2022-2023. This will increase the budget by \$8,541 for receipt of the DOH EMS County Award Grant.

### **PUBLIC COMMENT**

Terry Witt inquired of the property purchased in Gulf Hammock previously rumored to be the location for a Chinese primate facility.

Comm. John Meeks addressed his concern by informing him of proposed Legislation to prevent the sale of property to those in communist government countries. He explained this is for future land purchases and could not affect transactions already made.
