## **SHERIFF'S OFFICE-911**

### Mike West, 911 Coordinator

Requesting Board approval of Resolution 2023-20 amending the final budget for fiscal year 2023 in the amount of \$39,219. This budget amendment is necessary to allow for additional funds received from the State E911 Board in the form of a Rural County Grant.

## **ROAD DEPARTMENT**

Requesting Board approval of Resolution 2023-19 authorizing a Construction and Maintenance Agreement with the Florida Department of Transportation and authorizing the execution of the Agreement, and all related documents, for Traffic Safety Improvements at the intersection of SR 121 and CR 336 located in Levy County, Florida.

Comm. Mills made a motion to approve Resolution 2023-19 as presented. Second was made by Comm. John Meeks and the MOTION CARRIES.

Audience members, Diane Garte and Sallie Ann Collins inquired of DOT's plans to improve this intersection and Mr. Duquette gave clarification.

## PROCUREMENT

Alicia Tretheway, Coordinator

A. Requesting Board approval of the lowest, most responsive, responsible bidder (Kenco Signs & Awning, LLC) ITB\_2023\_011 for an Outdoor Digital LED Sign Board in the amount of \$32,500. This will replace the existing sign at the Annex property.

Comm. Mills made a motion to award the bid to Kenco Signs & Awning, LLC for an Outdoor Digital LED Sign Board as presented. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

B. Discussion on putting out a bid for the Road Department's roof to be repaired, and for the Maintenance Department to repair the restroom at the Road Department. The County received \$192,035 in sales at the most recent auction, and staff would like to use some of those funds for the above noted necessary repairs.

Comm. Mills made a motion to advertise for bids for the repair of the Road Department roof as presented. Second was made by Comm. Hodge and the MOTION CARRIES.

C. Requesting Board approval of the Project 25 Public Safety Radio Network Purchase and Installation Agreement between Communication International, Inc., and Levy County. The Total Agreement Price is \$8,898,238.21. Mrs. Tretheway stated the Board authorized negotiations with the company in October and the item before them is the result.

Clayton Drew from DPS spoke regarding the Radio Network explaining how this system will integrate all radio systems allowing all county departments to communicate with one another.

Comm. Mills made a motion to approve the Project 25 Public Safety Radio Network Purchase and Installation Agreement with Communication International, Inc. as presented. Second was made by Comm. Hodge and the MOTION CARRIES.

## **NON-AGENDA ITEM**

Wilbur Dean, County Coordinator requested Board approval to send notice terminating the contract with Dewberry for engineering and related services and to authorize the County Coordinator to sign the Notice of Termination.

Comm. Mills made a motion to approve the Notice of Termination with Dewberry and to authorize the County Coordinator to sign as requested. Second was made by Comm. John Meeks and the MOTION CARRIES.

## **PUBLIC COMMENT**

Linda Cooper spoke to the Board inquiring of how long Dewberry had been doing business with Levy County. Mr. Dean explained they had been working with Levy County since 2014. Poor performance was a factor in making the decision to terminate the contract.

## **ELECTED OFFICIALS**

Sheriff McCallum spoke of "Law Day", thanking the Commissioners for attending. He also stated the Annual Law Enforcement Memorial Service will take place in Williston at Heritage Park tomorrow at 10:00 A.M.

Sue Beaudette, Town of Bronson spoke of the ribbon cutting ceremony at the new Bronson Fire Station held recently. She also stated there is a meeting taking place today of the Suwannee River Water Management District and they are recommending the Waccasassa Water and Wastewater Pipeline Cooperative Project move forward to DEP. This pipeline project will provide water from Bronson to Otter Creek and Cedar Key. Ms. Beaudette reminded everyone of the next Beautify Bronson Day scheduled for Saturday, May 20<sup>th</sup>.

Ms. Hernandez, from Senator Perry's office stated \$350,000 had been approved in the State's budget for the Florida Heritage Equestrian Trail, which includes many stops in Levy County.

Steve Schwing, Inglis Mayor spoke of a new program implemented to send alerts citizens of Inglis and upcoming events by a phone app.

## **COMMISSIONERS' REPORTS**

**Comm. Mills** spoke of Rural County Days held in Tallahassee, which she and the other Commissioners attended. Other events Comm. Mills spoke of: National Day of Prayer; which took place last Thursday; Yankeetown's 100 Year Celebration being planned for October; congratulations to Chiefland FFA member, Hunter Sharp, selected to run for a State FFA office; SHIP funding for the upcoming year from the State.

**Comm. Rock Meeks** also spoke of Rural County Days and of a consultant he will meet with Thursday concerning land development.

**Comm. Hodge** stated he enjoyed the opportunity to meet new people at Rural County Days and reported of his attendance of Law Day.

**Comm. John Meeks** stated there is a Hurricane Kick-Off meeting scheduled for Monday, May 22<sup>nd</sup> at 10:00 A.M. He will be attending a Legislative Wrap-up on Wednesday with the Florida Association of Counties. Comm. John Meeks then spoke of the item Comm. Brooks had placed on the agenda to discuss calendar conflicts with the upcoming Uses Workshops and Budget Workshops. He stated he would be in favor of postponing the remaining Uses Workshops until a later date.

Comm. John Meeks congratulated the Williston Baseball and Softball Teams for their District Championships.

Comm. Brooks also spoke of attending Rural County Days, stating Levy County was well represented.

The Commissioners agreed to postpone the remaining Uses Workshops until a later date to be determined.
