MINUTES

The minutes for the Regular Meeting and Land Uses Workshop held May 8, 2023 were presented for Board approval.

Comm. Mills made a motion to approve the minutes for the Regular Meeting and the Land Uses Workshop held on May 8, 2023 as presented. Second was made by Comm. Hodge and the MOTION CARRIES.

AGENDA ADDITIONS, DELETIONS, MODIFICATIONS

Comm. John Meeks made a motion to approve the agenda with no changes. Second was made by Comm. Mills and the MOTION CARRIES.

PUBLIC COMMENT

Rose Fant addressed the Board regarding the composting issue encouraging them to make a decision regarding regulations for this type of business in Levy County before September.

BUSINESS OR INFORMATIONAL ITEMS

SUWANNEE RIVER WATER MANAGEMENT DISTRICT

Leroy Marshall, Chief Professional Engineer for the office of Agriculture Environmental Projects for the Suwannee River Water Management District spoke to the Board providing an update of the Waccasassa Water & Wastewater Cooperative Project. Mr. Marshall stated in December of 2021, the District received calls and a meeting was held in Bronson with representatives from the Town of Bronson, Town of Otter Creek, City of Cedar Key and a representative from the Board of County Commissioners to discuss the possibility of a Regional Water/Wastewater entity. During Commissioner's Reports from the Regular Board Meeting held July 5, 2022, Comm. John Meeks spoke of a meeting he attended at noon at the Bronson Town Hall regarding the newly formed Wacasassa Water Supply Group supplying water from Bronson to Otter Creek, Cedar Key and unincorporated areas along the way. Mr. Marshall stated a feasibility study was done in September of 2022, which indicated a water plant could be constructed in Bronson with water lines running to Otter Creek and extending to Cedar Key. A sewage plant could then be constructed in Cedar Key to pipe sewage back through Otter Creek to Bronson where it could be treated and used as reclaimed water or treated well enough it could be returned to the ground to recharge the aquifer. The study indicated the price for this water plant would be around \$36 million and the price for the wastewater plant would be around \$69 million. Upon completion of the study and review, the District then made a recommendation to their Board for the applications made by Bronson, Otter Creek and Cedar Key for funding to be forward to DEP. In May of 2023, the two projects were submitted by the District to DEP along with other projects, for funding in the amount of \$119 million for review by them and AWS (Alternative Water Supply). Application for AWS/Springs funding was submitted by the three entity's in December of 2022. The Towns of Bronson, Otter Creek and City of Cedar Key are forming a Cooperative and bylaws are being drafted in order to receive funding, if awarded.

Audience member, Linda Cooper spoke against the County being involved with Waccasassa Water & Wastewater Cooperative Project.

TOURIST DEVELOPMENT

Requesting Board approval of funding a Withlacoochee Gulf Preserve tourism project in the amount of \$11,400. This project will be supported through funding of the Tourist Development Tax.

Comm. Mills made a motion to approve funding of a Withlacoochee Gulf Preserve tourism project as requested. Second was made by Comm. John Meeks and the MOTION CARRIES.

PROCUREMENT

Alicia Tretheway, Coordinator

A. Requesting Board approval of Resolution 2023-23, approving an application for a Community Planning Technical Grant from the Florida Department of Economic Opportunity to Develop a Community Action Plan for Restoration of Flows to the Lower Withlacoochee River; providing direction and authorization to the County Coordinator, or Designee; and providing an effective date.

Comm. John Meeks made a motion to approve Resolution 2023-23 as requested. Second was made by Comm. Hodge and the MOTION CARRIES.

B. Requesting Board approval of the recommended ranking of Code Enforcement Special Magistrate and authorize award of the Form of Contract to the highest ranked proposer. The three proposals were ranked in the following order:

Braswell Law, PLLC	85.3
Norm D. Fugate, P.A.	83.6
Weiss Serota Helfman	77.6

Comm. Mills stated she had concerns of the cost to hire Braswell Law, even though they scored higher. She inquired of the other Commissioners opinions. Comm. John Meeks expressed concerns of conflict of interest with Norm Fugate representing clients with Code Enforcement cases.

Norm Fugate spoke to the Board and addressed concerns mentioned by Comm. John Meeks. Mr. Fugate stated if a conflict were to arise, he would defer to an alternate firm.

Comm. John Meeks stated he was in favor of selecting an additional alternate firm when the Form of Contract was awarded.

Comm. Mills made a motion to award the Form of Contract for Code Enforcement Special Magistrate to Norm D. Fugate, P.A., and to select Braswell Law, PLLC as alternate. Second was made by Comm. John Meeks.

Atty. Shalley stated the Board would need to indicate they had thoroughly reviewed the proposals and rank them using a similar form of what County staff used. If a conflict of interest arose, the Special Magistrate would need to recuse themselves from judging such a case and an alternate would need to be appointed. Atty. Shalley stated the results of a separate ranking of proposers could be presented to the Board at the next meeting.

Following discussion, Comm. Mills rescinded her earlier motion and made a new motion to direct the Commissioners to individually review and score the proposals. The results would be presented at the next meeting for the Board's consideration. Comm. John Meeks rescinded his earlier Second. For the current Motion, Comm. John Meeks made a Second and the MOTION CARRIES.

C. Requesting Board approval of Task Assignment 2023-4 between Levy County and Kimley-Horn and Associates, Inc. for the Landscape Design at the Levy County Government Center in the amount of \$11,500.

Comm. Mills made a motion to approve Task Assignment 2023-4 as presented. Second was made by Comm. John Meeks and the MOTION CARRIES.

D. Requesting Board approval of Task Assignment 2023-5 between Levy County and Kimley-Horn and Associates, Inc., for the Park Schematic Design at the Levy County Government Center in the amount of \$20,800, and a not-to-exceed labor fee plus expenses basis with the maximum fee of \$3,700 will be billed on an hourly basis.

Comm. Mills made a motion to approve Task Assignment 2023-5 as presented. Second was made by Comm. Rock Meeks and the MOTION CARRIES.

PUBLIC COMMENTS

Justin Ford, Dewberry representative spoke regarding the decision made by the Board to remove Dewberry from the University Oaks project. He stated while he respected the Board's decision, the company has since made changes and he requested the Board give them the opportunity to finish the project.

Comm. Brooks stated this was not an agenda item and would require a vote for a non-agenda item in order to take action. It could, however, be placed on the agenda for an upcoming meeting.

Comm. John Meeks confirmed with Mrs. Tretheway the opportunity to re-submit a proposal for this project could be done, as they would still be within the deadline. Dewberry would then be considered with any other proposers.

ELECTED OFFICIALS

Mayor Steve Schwing, Town of Inglis reported of attending and taking part in the graduation ceremony at Yankeetown School along with the Yankeetown Mayor. Mayor Schwing also stated the Fugate and Fugate Law Firm had been recently hired as the Attorney for the Town of Inglis.

Sue Beaudette, Town of Bronson, stated a fireworks celebration will take place at the park in Bronson on July 4th. Festivities will begin around 7:00 P.M. and will include several food vendors and they are seeking entertainment for the event.

Representatives of Senator Perry's Levy County office location were in attendance and stated they were available for any questions or concerns the public may have.

COMMISSIONERS' REPORTS

Comm. Rock Meeks reported the Chiefland Watermelon Festival was well attended.

Comm. Mills reported of the Memorial Day Service in Yankeetown, which she attended. An Affordable Housing meeting will be held in Williston on June 14th at 10:00 A.M. Comm. Mills also mentioned the quality of the sound system in the Commissioners meeting room indicating she inquired if this could be improved.

Comm. Hodge also reported of the large attendance of the Chiefland Watermelon Festival.

Comm. John Meeks reminded everyone of the Flag Day Ceremony taking place on June 14th at 9:00 A.M. in front of the Levy County Government Center. The 4-H day camps are underway with this week's activity is shooting sports. The Rotary Club Fishing Tournament held recently had 56 boats participating and the event raised nearly \$18,000. Comm. John Meeks then provided Legislative updates.

Comm. Brooks reported of continuing efforts made by staff to have items presented for Board consideration as soon as possible regarding composting business regulations in Levy County.
