Comm. Brooks introduced Layla DeVries, an American Government student in attendance observing local government at work.

BARNETT, FRONCZAK, BARLOWE & SCHULER ARCHITECTS

Douglas S. Barlowe, AIA

Presentation of conceptual design drawings and color renderings for the Levy County Courthouse Renovation Project. Mr. Barlowe pointed out some changes made at the request of the Commissioners at the last presentation.

Following the presentation, consensus was given by the Commissioners to move forward with this project.

LEVY COUNTY COMMISSIONER – JOHN MEEKS, VICE-CHAIRMAN

Comm. John Meeks stated he had been approached regarding the speeding on Main Street in Bronson and inquired of the other Commissioners what their thoughts were regarding this concern.

Audience member, Natalie Thomas spoke regarding the safety issue of Main Street. She stated it would make it safer for residents and children for sidewalks to be added, rather than speed bumps.

Alice LaLonde stated a traffic study could be done by the Road Department. Once this has been completed, she would bring the information back to the Board for them to decide what action to take.

COUNTY COORDINATOR

Wilbur Dean

- A. Requesting Board approval of Preliminary Rate Resolution No. 2022-33, EMS Tax Assessment for Fiscal Year 22-23. The rates will remain the same as last year.
- B. Requesting Board approval of Preliminary Rate Resolution No. 2022-34, Fire Protection Tax Assessment for Fiscal Year 22-23. The rates will remain the same as last year.
- C. Requesting Board approval of Preliminary Rate Resolution No. 2022-35, Solid Waste Disposal Tax Assessment for Fiscal Year 2022-23. The rates will remain the same as last year.
- D. Requesting Board approval of Preliminary Rate Resolution No. 2022-36, Roadway Maintenance Tax Assessment for Fiscal Year 2022-23. The rates will remain the same as last year.

Following Mr. Dean reading the title of each Resolution into public record, Comm. John Meeks made a motion to approve all Preliminary Rate Resolutions as presented. Second was made by Comm. Brooks and the MOTION CARRIES. Comm. Rooks voted NO on Preliminary Rate Resolution No. 2022-36, Roadway Maintenance Tax Assessment.

Audience members who spoke regarding these items were: Terry Witt and Dana Sheffield.

Comm. Rooks asked Mr. Blanton to provide an explanation for the audience of why it was necessary for the Solid Waste and EMS rate to remain the same. Mr. Blanton stated information and reasons for not increasing the rates this year, but reminded the Board these rates would need to be increased soon.

DEPARTMENT OF PUBLIC SAFETY

Alesha Renaudo, on behalf of Mitch Harrell

A. Requesting Board approval of a budget amendment in the amount of \$130,000 from Contingency Reserves to the Operating Budget. Due to the unexpected increased cost of fuel, additional funds are needed in the gasoline, oil, and lubricants line to cover fuel expenses for the remainder of the budget year.

Comm. John Meeks made a motion to approve the budget amendment as requested. Second was made by Comm. Brooks and the MOTION CARRIES.

B. Requesting Board approval and the Chairman's signature on the Lease Amendment between Fowlers Bluff Volunteer Fire Department, Inc. and Levy County. The Amendment will extend the term of the Lease of the Fowlers Bluff Fire Station for an additional 5 years. (ending July 11, 2027). Mrs. Renaudo stated there is no cost for this lease.

Comm. Rooks made a motion to approve the Lease Amendment with the Chairman's signature as requested. Second was made by Comm. John Meeks and the MOTION CARRIES.

C. Requesting Board approval and the Chairman's signature on the letter provided accepting a donation of multiple sets of extrication equipment from Marion County. Mrs. Renaudo stated there are 5 sets of equipment being donated.

Comm. John Meeks made a motion to approve the acceptance letter with the Chairman's signature as requested. Second was made by Comm. Brooks and the MOTION CARRIES.

Wilbur Dean, on behalf of Marlon Gayle, Housing Planner

A. Requesting Board approval of Deferred Payment Loan Agreement in the amount of \$30,000 for MaShonda T. Solomon, PA #594 for a new unit in Williston, Florida.

Comm. Brooks made a motion to approve the Deferred Payment Loan Agreement, PA #594 as presented. Second was made by Comm. John Meeks and the MOTION CARRIES.

B. Requesting Board approval of Deferred Payment Loan Agreement in the amount of \$30,000 for Roberto Carlos Beltran Montes and Stephany Serrano Delgado, a married couple, PA #599 for a new unit in Morriston, Florida.

Comm. Brooks made a motion to approve the Deferred Payment Loan Agreement, PA #599 as presented. Second was made by Comm. Rooks and the MOTION CARRIES.

PUBLIC COMMENTS

Mike and Holly Walker expressed to the Board their concerns of the two commercial, industrial businesses operating across the road from her property in Morriston, Russ Ironworks and Russ Welding & Machine. She stated the pollution and noise from the operation of these businesses six days a week has become unbearable. Upon contacting Code Enforcement, Mrs. Walker was informed the business is operating within the allowed use.

Natalie Thomas gave an update to the Board on behalf of the Affordable Housing Committee of a recent meeting in which they are trying to bring in Habitat for Humanity projects to Levy County.

Sheriff McCallum spoke to the Board of the large expense of a sentenced inmate, which has and will continue to be hospitalized. He stated this would likely cause the Sheriff's Department to request additional funds to cover the expense.

COMMISSIONERS' REPORTS

Comm. Rooks and **Comm. Brooks** spoke of the recent Florida Association of Counties conference they attended. Comm. Brooks spoke extensively of cyber-security.

Comm. John Meeks spoke of a meeting he attended at the Bronson Town Hall regarding the newly formed Wacasassa Water Supply group and their plan for the Town of Bronson to supply water to Otter Creek and Cedar Key. Discussion followed of the Board's desire to be a part of this project.

Comm. John Meeks reported of another spill in Valdosta, which flows from creeks into the Suwannee River. Comm. John Meeks stated he had been appointed by the Florida Association of Counties as Chairman for the Institute of County Governments.

Audience member, Dana Sheffield spoke of the water project item.
