Comm. Mills made a motion directing Atty. Shalley to draft Ordinances as discussed. Second was made by Comm. John Meeks and the MOTION CARRIES.

Diane Garte encouraged the Board to add restrictions into the Ordinance language regarding dumping. Jeff Hardison spoke of Comm. John Meeks and pointed out how much he works for the people of Levy County.

Sallie Ann Collins spoke regarding the Sand Mine application.

Jan Noble encouraged the Board to be sure the language in the Ordinances prohibiting Composting businesses is made clear.
