- A. Requesting Board approval of Resolution 2021-105 adopting the FY22 Tentative Millage. Mr. Blanton stated the millage rate presented is 9.0000, which represents a 4.86% increase over the rolled-back rate of 8.5825 mills.

Comm. John Meeks asked if there was anyone in the audience wishing to speak for or against the item presented. There were none.

Comm. Rock Meeks made a motion to approve Resolution 2021-105 as presented. Second was made by Comm. Rooks and the MOTION CARRIES.

- B. Mr. Blanton requested Board approval of Resolution 2021-106 adopting the FY22 Tentative Budget at \$113,147,676 and stated there had been no changes to the tentative budget since it was presented on August 3<sup>rd</sup>.

Comm. John Meeks asked if there was anyone in the audience wishing to speak for or against the item presented. Audience member, Terry Witt inquiring of the cost of the Sheriff's communication system. Mr. Blanton and Ali Tretheway responded the total cost has not yet been finalized and no RFP has been created.
