More specifically the portion facing HWY 41.

Comm. Rock Meeks asked if anyone in the audience wished to speak for or against against the item. Maria Wise spoke regarding the zoning designation.

B. <u>Public Hearing</u> – Requesting Board approval of Ordinance 2022-16; Clay Sweger with EDA Consultants, representing the Commission to amend the Zoning Map Atlas by rezoning certain real property consisting of 9.5 acres (MOL), changing from Urban Medium Density Residential (UMDR) to Commercial (C) on a portion of parcel number 0475100000 located in Section 30, Township 12, Range 19. More specifically the portion facing HWY 41.

Comm. John Meeks made a motion to approve the proposed 2023 Levy County Board of County Commissioner regular scheduled meeting dates as presented. Second was made by Comm. Brooks and the MOTION CARRIES.

Audience member Terry Witt, inquired if the Board would consider moving the meetings immediately following a Monday holiday to Thursday evenings. Comm. John Meeks responded the Board wished to remain consistent with the day of the meeting by moving the time only for the four meetings affected by this change.

C. Requesting Board approval of the Amendment between the Florida Forest Service and Levy County. This is an amendment to Contract #1218 dated 6/30/88. The fire protection acres increased from 517,250 to 527,209. This increased our annual cost from \$36,207.50 to \$36,904.63, a difference of \$697.13.

Comm. John Meeks made a motion to approve the Amendment with the Florida Forest Service as requested. Second was made by Comm. Brooks and the MOTION CARRIES.

B. As well as requesting the Board's approval to remit Intergovernmental Transfer (IGT) Funds to AHCA not to exceed \$265,794.18 when invoiced by AHCA.

Atty. Shalley offered information regarding this agreement and urged the Commissioners to understand what they are agreeing to.

Jared Blanton expressed concerns of the agreement and the period of time in which money returns to the County.

Alesha Renaudo, with Department of Public Safety also spoke regarding this item.

Comm. John Meeks made a motion to approve the Public Emergency Transportation (PEMT) Letter of Agreement with the State of Florida, Agency for Health Care Administration (AHCA) with the Chairman's signature upon completion of signed agreements and the survey of approval other entity's which have participated in this program to remit Intergovernmental Transfer Funds to AHCA as requested. Second was made by Comm. Brooks and the MOTION CARRIES.

SHIP

SOLID WASTE

Comm. Brooks request on behalf of Rod Hastings for Board approval to Amendment #1 to Agreement #SC220 between the Florida Department of Environmental Protection and the Board of County Commissioners. The request is to extend the agreement for a 6-month period beginning September 30, 2022 and remain in effect until March 31, 2023. Two Ford F-250's were to be purchased, but with the delays in manufacturing, they are not available within the period allowed. The extension will allow for the purchase of the 2 trucks, preventing the loss of available funds.

Comm. Brooks made a motion to approve the Amendment to the Agreement as requested. Second was made by Comm. John Meeks and the MOTION CARRIES.

PUBLIC COMMENT

Dana Sheffield thanked the Board and staff for their work on the budget this year.

Comm. Rock Meeks read into public record an email received from Chris Oldham expressing his concern of the purchase of property in Levy County by a biological research company, JOINN Laboratories, and of the alleged plans for the property.

Audience members, George Henry, Renate Cannon, Brian Weathers and Terry Witt also spoke regarding this item.

Comm. Rooks requested Atty. Shalley send a letter to FWC for a current list of permitted facilities, including addresses, with primates located in Levy County.

Comm. Rooks requested the Commissioners wear pink in October for Breast Cancer Awareness Month.

Comm. John Meeks reported of the meeting held recently in Rosewood concerning the proposed water/wastewater project. He also encouraged everyone to think of concerns or issues to have presented at the Legislative Delegation hearing, taking place in Levy County sometime after November.

A FAILURE TO MAKE ANY REQUIRED DISCLOSURE CONSTITUTES GROUNDS FOR AND MAY BE PUNISHED BY ONE OR MORE OF THE FOLLOWING: IMPEACHMENT, REMOVAL OR SUSPENSION FROM OFFICE OR EMPLOYMENT, DEMOTION, REDUCTION IN SALARY, REPRIMAND, OR A CIVIL PENALTY NOT TO EXCEED \$10,000.
