#### **TRANSIT**

# DEPARTMENT OF PUBLIC SAFETY

Mitch Harrell, Director

A. Requesting Board approval and the Chairman's signature on the Levy County Department of Public Safety (EMS) Certificate of Public Convenience and Necessity (COPCN). This COPCN is necessary for the County to continue operating ALS/BLS services permitted by the State.

Comm. John Meeks made a motion to approve the Levy County Department of Public Safety (EMS) Certificate of Public Convenience and Necessity as requested. Second was made by Comm. Brooks and the MOTION CARRIES.

B. Requesting Board approval to purchase two (2) Lifepak 15 monitors from Stryker in the amount of \$38,231.40 per quote received. These monitors are used on the EMS transport units and will replace obsolete units.

Comm. John Meeks made a motion to approve the purchase of two (2) Lifepak 15 monitors from Stryker as requested. Second was made by Comm. Rooks and the MOTION CARRIES.

C. Requesting Board approval to purchase two (2) Ford F250's from Duval Ford utilizing the Bradford County Sheriff's Office Bid Pricing for a total of \$97,692.50. These vehicles will be used as LCDPS command/supervisor vehicles and the current vehicles will be rotated into the LCDPS fleet for other uses or as backup units. Mr. Harrell explained the purchase of one of the vehicles was originally budgeted for last fiscal year, however, the vehicle would not be delivered until this fiscal year. These funds were transferred into the current fiscal year. The second vehicle is budgeted for the current fiscal year.

Comm. Rooks made a motion to approve the purchase two (2) Ford F250's from Duval Ford as requested. Second was made by Comm. Mills and the MOTION CARRIES.

D. Requesting Board approval to order and purchase two (2) Ford F550 ambulance chassis from ETR for an estimated cost of \$131,152. Mr. Harrell explained the order banks are expected to be open in November for only three dates for the 2023 model year. They have not yet released pricing and the amount listed is the best estimate available.

Comm. John Meeks made a motion to approve the order of two (2) Ford F550 ambulance chassis from ETR as requested. Second was made by Comm. Mills and the MOTION CARRIES.

#### EMERGENCY MANAGEMENT

#### **PROCUREMENT**

B. Requesting Board approval of Amendment No. 1 to the Agreement between Levy County and Wright-Pierce, Inc., for the Shell Mound Boat Ramp Improvements. Additional testing services need to be performed from the proposed dredge for full containment. The fee for this shall be increased by \$9,095 from \$93,850.

Comm. Brooks made a motion to approve Amendment No. 1 to the Agreement with Wright-Pierce, Inc. as requested. Second was made by Comm. John Meeks and the MOTION CARRIES.

C. Requesting Board approval of the ranking of firms for the P25 Project and authorize negotiations with the top scored proposer, Communications International. The top three bids were from Communications International, 96, Motorola, 85.25 and Williams Communications, 75.88.

Comm. Brooks made a motion to approve the ranking of firms for the P25 Project and authorize negotiations with the top scored proposer, Communications International as requested. Second was made by Comm. John Meeks and the MOTION CARRIES.

D. Requesting Board approval to request our allocation of the Local Assistance and Tribal Consistency Funds (LATCF) in the amount of \$151,542.50. These funds will be distributed in two separate payments of \$75,771.25, one in FY22 and one in FY23. There is a very broad discretion on the use of these funds. Recipients may use these funds on any governmental purpose other than lobbying activity.

Comm. John Meeks made a motion to approve requesting the Levy County's allocation of the Local Assistance and Tribal Consistency Funds (LATCF) as requested. Second was made by Comm. Brooks and the MOTION CARRIES.

#### **COMMISSIONERS' REPORTS**

Comm. Mills stated she was appreciative and looked forward to serving the citizens of Levy County as Commissioner.

**Comm. John Meeks** helped in delivering tarps to Okeechobee County, which would then be delivered to Desoto County as travel to Okeechobee County was still limited due to the storm. The Cedar Key Seafood Festival was well attended over the weekend

**Comm. Brooks** spoke of a Broadband Conference coming up in January and asked Ali if all Commissioners could be emailed with the information.
